### **Housekeeping & Opening Discussion**

- Members joined from various locations; casual opening conversation about holidays, school return, and weekend activities.

### **Agenda Planning for December Meeting**

- Committee confirmed purpose of meeting was to determine December agenda items.
- Reviewed district calendar: boundary workshops on Dec 8-9, Roundtable on Dec 9.
- Noted discrepancies in district calendar postings, missing training entries.

### **Boundary & Redefining Schools Update**

- Board expected to discuss redefining schools primarily on Dec 8, overflow on Dec 9.
- No additional information provided to DAC despite expectation.
- Members requested clarity on missing demographic data and criteria for deliberation.

# Academics – Key Issues & Questions

## **Testing Volume Concerns:**

- Significant discussion on excessive testing, especially for K-2.
- Teachers feel pressured by district staff; parents expressing frustration.
- Request: Provide list of required vs optional tests.
- Request: Clarify teacher autonomy under BTU contract.
- Request: Address testing culture and stress placed on children.
- Request: Compare Broward testing load with neighboring districts.

### **Performance Matters Platform:**

- Widely described as clunky and difficult for students and teachers.
- Questions for district:
- What is being done to resolve platform issues?
- Why was it adopted without proper rollout or communication?
- When will families receive training/communication on its use?
- Are teachers fully able to access data?

### Computer Literacy & Typing:

- Follow-up requested on long-promised typing instruction.
- Concern that students must test on computers without proper preparation.

### **Other Academic Topics**

- ACE expansion: Committee requested cost details for middle vs. high school.
- Concerns raised that principals are unaware of available funding for expansion.
- Noted large amounts withheld by district (example: ~\$400k at one school).

#### **Technology & Platform Concerns**

- Members observed repeated pattern of district adopting tools without adequate implementation (Here Comes the Bus, Maximo, Focus).
- Request: Confirm whether Performance Matters allows parents to view itemized test results.
- Request: District must provide proper rollout, training, and communication.

### **Requests & Action Items**

- Provide written clarification of required vs optional testing.
- Provide BTU contractual requirements related to testing and autonomy.
- Obtain comparable district testing loads (Palm Beach, Miami-Dade).
- Confirm attendance of academic leads (Guy + elementary representative).
- Request summary of improvements planned for Performance Matters.
- Confirm ACE expansion funding amounts and timelines.
- Verify whether DAC needs to create survey on testing culture.
